Decision: 1. Annual planning will be prepared by each department and implementation of same as per schedule for academic year 2016-17.

According to procedures for 2<sup>nd</sup> cycle given on NAAC website, submission of LOI should be done 6 months before expiry of validity of certificate which is 4<sup>th</sup> January 2018 so LOI must be submitted before 4<sup>th</sup> July 2017. Prior to submission of LOI uploading of SSR on institutional website must be done one month prior to submission of final document under intimation to NAAC so one month prior to submission of LOI SSR should be uploaded on institutional website i.e before 4<sup>th</sup> June 2017.

Result of LOI will be communicated to institute by NAAC within 15 days.

Institute has to submit SSR within 2 weeks of acceptance of LOI by NAAC.

NAAC will decide dates of visits after receipt of SSR i.e in 3 weeks.

NAAC visit will complete within one month

NAAC new grading system and newly added other procedures related to the accreditation and assessment were discussed and brought in notice of IQAC members.

IQAC members were informed about each and every aspect of 2<sup>nd</sup> cycle of assessment and accreditation and given instruction to take further necessary action for 2<sup>nd</sup> cycle of NAAC assessment and accreditation.

Subject 3: Discussion on 2nd cycle of Assessment and Accreditation by NAAC.

In this regard separate meetings were conducted and each criterion was deeply discussed by IQAC coordinator and In charge staff member of concerned criterion.
